

Engage our Furniture Fund partner Egans to assess, buy, collect, resell and repurpose to avoid landfill.

The resulting rebate can be donated to the Property Industry Foundation. We believe that every young Australian deserves a safe and secure place to sleep. The Foundation brings together the property and construction industry to build homes for homeless youth.

How it works

- 1. Egans arranges a **FREE quote** for the removal of your unwanted assets and their resell value.
- 2. Assets are safely taken away to be resold, reused, recycled or disposed.
- **3.** You receive your rebate from Egans which can be donated to The Property Industry Foundation, along with a taxdeductable invoice and a sustainability statement.



*You negotiate the contract for the relevant services directly with Egans on terms

acceptable to you, and Egans is solely responsible for delivering the services to you (Property Industry Foundation is not part of this process). If you choose to, you can turn any sale proceeds into a donation to Property Industry Foundation.

Where do your donations go?

The Property Industry Foundation believes that as the creator of new communities, our industry can and should play a role in addressing the issue of youth homelessness.

To make a tangible impact on this issue, the Property Industry Foundation leads and coordinates the efforts of our industry, along with our charity partners, to build homes for homeless youth.

We do this it through the **<u>PIF House Program.</u>**

This is a unique collaboration bringing the property and construction industry together to build homes for homeless youth. Youth homeless charities such as The Salvation Army and Lighthouse Foundation ask the Foundation to build or renovate a home for homeless youth.

The Foundation then fundraises to build this home, with each \$1 raised being matched through in-kind donations of skills, labour and goods by the property and construction industry. For example, a six-bedroom house with a build price of \$600k can be delivered for \$300k or less.

This means for every dollar donated, we deliver \$2 worth of value.



When young people are given safe housing and the right support, the benefits are felt not just by them, but across society. They go on to find employment, contribute to the economy and engage in their community.

"All of the residents we house in this home have experienced significant trauma in their lives.

We have 1 ex-resident who is still in Marist's care while living independently, as she is 17. She has 2 jobs and is saving up for her own car, which is a great success story."



- Avoid the costly and long-winded issue of disposing of Furniture, Fixtures and Equipment during a company tenant's exit strategy from a commercial premise
- Minimising the items which generally end up in landfill.

The Solution

Altis engaged Egans, the removalist partner of the Furniture Fund, to assess, pick up, resell, re-use and disassemble the excess office furniture, ensuring that nothing was wasted.

The Benefits

4,453kg was diverted from landfill, enabling Altis to demonstrate its commitment to recycling within a circular economy, as well as action on Climate Change.

Altis donated the proceeds from the furniture sold to the Property Industry Foundation, making a significant contribution to supporting homeless youth. "Altis recently engaged Egans Asset Management Pty Ltd to assess, pick up, re-use, and re-sell excess office furniture at 191 Salmon St, Port Melbourne, demonstrating our commitment to recycling and the circular economy. All proceeds were donated to the Property Industry Foundation. "

- 1. Egans arranged a free quote for the removal of all unwanted assets and assessed their resale value
- 2. Egans removed all assets to be resold, reused, recycled, deposed of.
- 3. Egans supplied Altis with a rebate along with a tax-deductible invoice and sustainability statement.
- 4. Altis donated the rebate to the Property Industry Foundation.

The GPT Group de-fits an office suite in support of homeless youth

GPT aims to be a positive contributor to environmental sustainability, which includes an objective to procure, use and recover materials in a closed-loop.

This objective supports Australia's transition to a circular economy and encourages us to focus on initiatives like the reuse of commercial furniture through the Property Industry Foundation's Furniture Fund.

The Challenge

- Avoid the costly and long-winded issue of the de-fit of an office suite at 8 Exhibition Street, Melbourne.
- Minimising the items ending up in landfill.

The Solution

GPT, alongside co-owners Kepple, used the Foundation's Furniture Fund to provide a fast, fuss-free, environmentally sustainable way to de-fit this office in the Melbourne CBD.

The Benefits

Through the Furniture Fund, GPT was able to reduce their environmental footprint by recycling furniture instead of having it go to landfill and turn their old furniture into a donation to go towards building homes for homeless youth.

Results

Industry research from the Better Buildings Partnership has demonstrated there is more material leaving commercial office buildings in Australian CBDs from defit and strip-out works each year than from everyday tenant operations, and most of this material goes straight to landfill.

"GPT has worked with its peers in the BBP to implement the BBP Strip-out Waste Guidelines and encourage greater reuse and recycling. The Property Industry Foundation's Furniture Fund is a great initiative that helps us do this, retaining the value of material and providing broader social and economic benefits."
